


## A THOUGHTFUL LEGACY TO HIS COMMUNITY

continued from page 1 aged by fires, and the site has some contamination issues and is currently being cleaned up by Brownfield Associates, environmental consultants. William Fischer, their principal hydrogeologist, will update us on what has transpired at this facility over the past two years and what is to take

PRESIDENT'S LETTER

place in the near future.

Property along Raphel Road runs through the history of GKCA from our founding in 1974 to the present. In the 1970s GKCA was formed to lead the fight against a County dump on Raphel Rd. In the 1980s GKCA signed a covenant with the developer of the Mt. Vista executive golf course which we supported with certain conditions agreed to by both parties. When the owner built a clubhouse much larger than the size approved, GKCA was thrown into another Raphel Rd. controversy. Once again, just recently, GKCA and the community rallied to fight a proposed school bus depot on the Schmidt property which is located between I-95 and the golf course. Within the last 2 years,

the golf course has been closed by the county which has not yet revealed plans for the future of the golf course or the Schmidt property. However, the County Department of Recreation is operating the property as a "passive" use park and soccer practice field. Finally, in 2010 the Maryland Transportation Authority bought the Rutkowski property which is on the other side of the golf course. Since then rumors have circulated about the uses to which the County and State might choose to commit for this very large section of our community.

If you are interested in learning about the future of these Raphel Road properties, come to the September GKCA meeting. Fifth District councilman David Marks has arranged for Melissa Williams of the MTA, State Senator JB Jennings, and State Delegate Kathy Szeliga to discuss the state's plans for the future of the Rutkowski and Schmidt parcels.
